Missions and Consulates should note that Statutory Instrument # 42 of 2005 - Section 4(2) provides a variation in fees for some nationals as outlined above. The application fee (non-refundable) mentioned above is retained by the respective Office, however all other fees must be remitted to the Government of Belize.

Please note that there are no fees or deposits payable by holders of Diplomatic & Official passports in cases where visas are needed.
